NORTHERN ARIZONA UNIVERSITY CAMPUS DINING CONTRACTUAL TERMS AND CONDITIONS

1. Conditions of Contract

- The Student, by signing the contract (explicit contract acceptance) or making payment(s), payment arrangements and/or using Dining Dollars (implied contract acceptance) is agreeing to be bound by these terms and conditions. The student is responsible for the full term of the contract.
- A student is excused from the contract under the following conditions is eligible for a prorated refund of the unused portion of their Dining Dollars.
 - The student withdraws from the University.
 - The students is leaving the University as required by an academic program (e.g., students teaching, study abroad programs, internship, etc.).
- It is the sole responsibility of the student to contact Northern Arizona University Campus Dining upon withdrawal from the University. Any refunds due to the student will be calculated from the date of official withdrawal from the University. A \$10.00 processing fee is assessed on all refunds.
- The University will assist Campus Dining in the collection of returned checks through the process of academic holds.

2. NAUCard (Dining Dollars are accessed with the NAUCard)

- Students are responsible for their NAUCard, and all charges made to their accounts. If a card is lost or stolen, it must be immediately reported to the NAUCard Office at (928) 523-1906. All transactions, including Dining Dollar purchases, made on a missing NAUCard not reported as lost or stolen are the responsibility of the student owning the card.

- Your NAUCard is the property of Northern Arizona University and is not transferable. Unauthorized use of your NAUCard, use by a party other than the person identified on the card, and tampering with or altering the card, warrant confiscation and possible disciplinary action by the University. If you are ill and need a meal picked up for you, please have your Resident Assistant or Residence Hall Director contact a manager at the Hot Spot or South Dining.

3. Dining Dollars

- Dining Dollars are accepted for all Northern Arizona University Campus Dining purchases.
- All student Dining Dollars expire at the end of the spring semester and must be used on or before May 9, 2009.
- Students are responsible for monitoring their own account balances and for all purchases made with Dining Dollars
- All deposits to and transactions on Dining Dollar accounts are final.

4. Dining Dollars Payments

- Northern Arizona University Campus Dining charges a \$25.00 fee for any returned checks.
- Dining Dollar Payments are due at contract initiation.

5. Contract Period

- The contract period is for the academic school year, August 20, 2008 – May 9, 2009. Registered students are financially obligated for the entire contract amount unless the student is excused from the plan in accordance with 1b.
