This form is provided to assist students with obtaining Arizona residency for tuition purposes. The normal one year requirement for residency can be waived for those students who can document the following criteria:

- (1) The student’s spouse has established residency in Arizona for at least one year and has demonstrated financial independence.
- (2) The student’s spouse is entitled to claim the student as an exemption for state and federal tax purposes.
